- This EOI does not guarantee selection for performance at the Burra Country Music Festival
- This is a COUNTRY MUSIC festival, therefore, your performance must contain no less than 80% Country Music content, unless specifically contracted for alternative genre.
- A panel will review EOI's. All applicants will be notified whether successful or not.
- If selected for the Festival, the BCME reserves the sole right to determine the acts/position within the programme.

- The principal contact will forward ALL correspondence on to other members of the group.
- Artists contracted to perform for the festival will receive a backstage pass and a full festival ticket.
